## President's Message

Last Saturday, I had the pleasure – and the honor - of being among the first of many activists from across the State to take part in a training for Basic Rights Oregon's new marriage equality Speakers Bureau. I found the first hour particularly energizing and enlightening as Thomas Wheatley, BRO's Organizing Director, brought us up to date on BRO's efforts to win the right for gays and lesbians to marry. I thought I would pass along the information that Thomas shared.

As I'm sure you remember, Constitutional Amendment 36 restricting marriage in Oregon to one man and one woman was passed by a 57 to 43 margin in 2004 and became law. A legal remedy to remove it through the courts was cut-off when the Oregon State Supreme Court refused to hear the case made by several Oregon same-sex couples that to bar them from the institution of civil marriage was unconstitutional. And in Oregon, repealing a constitutional amendment does not fall within the purview of the legislature. Only the people of Oregon can amend the State constitution or repeal an existing amendment. So, the only path for repealing Constitutional Amendment 36 is by vote.

Since that election in 2004, the public's attitudes towards marriage equality have shifted considerably. In fact, attitudes towards the right for gay and lesbian couples to participate in civil marriage are evolving more rapidly than any other social issue. As of today, five States and the District of Columbia embrace marriage equality. Twenty states have a constitutional amendment banning same-sex marriage. To date, no state has overturned a constitutional amendment barring marriage equality by a vote of the people; but, as the nation looks on, Oregon may well be the first.

Over the course of the summer of 2010, BRO knocked on thousands of doors throughout the metro

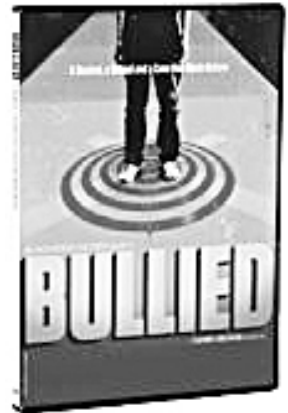

area, asking regular folks if they support marriage equality or why they oppose it. At this time, 1/3 of the respondents to BRO's campaign fully support marriage equality; 1/5 believe that gays and lesbians should have "all the same rights" - just not access to civil marriage, and 1/5 believe that gays and lesbians deserve no legal protections at all. That 1/5 that believe in rights but struggle with the word "marriage" are the people that slowly - but surely -we need to bring to our side.

When you hear the word "marriage" what do you think of? Many people will say "family" or "commitment." Perhaps it means "children"; or "companionship", the

comfort of growing old with your dearest friend. An interesting poll in Oregon was recently taken: when straight couples were asked why they chose to marry, most responded that they did it for "love and commitment." But when those same straight couples were asked why gay and lesbian people might want to marry, they answered that it was for the rights that marriage brings. A full 1/3 responded that they didn't know. And that's where our challenge lies. To win marriage equality in Oregon we must convince about 100,000 Oregon voters of what we already know: that marriage is about love and commitment. It is about standing up in front of family, friends and community and pledging to love and nurture one another come what may. And that those feelings are the same regardless of who you love.

Over the course of the next couple of years, expect to hear a lot of talk about marriage equality in Oregon. I'm sure you've already seen the ads currently airing on television with straight couples explaining how they came to embrace marriage equality. If you're inspired, join us in the conversation. Look for the article in this issue of the Portland Voice by BRO's Kyle White to learn how you can get involved today – especially if you're a mom.
